REFUNDS

Bitches in season will not be admitted to the trial. Any exhibitor with an entered bitch in season, on the trial date, will be refunded the entry fee, less \$3 per run (each day), upon written certification from a veterinarian. Notification must be in the hands of the trial secretary no later than 30 minutes before the start time on the date of the trial.

Injuries – Dogs that cannot compete due to an injury will be given a partial refund minus \$6.50 per run / per day. In each case the request must be accompanied by a certificate of a veterinarian and given to the Trial Secretary no later than 30 minutes before the start time on the date of the agility cluster on Friday, January 13, 2017.

- Overnight service **MUST** be mailed through USPS and you **MUST** check **AND** sign the **"NO SIGNATURE REQUIRED"** waiver box, as the Trial Secretary will not be present to sign for your entries.
- Be sure to include the correct fees. Check or money order only – no cash. Overpayments less than \$10 will not be refunded. Only worker vouchers from 2016 SCCTC/DOTC January trial will be accepted.
- All entries must be submitted on official AKC agility entry forms, one dog per entry form. Photocopies of front & back will be accepted only if legible and official AKC size.
- Entries will not be accepted without signature, back of entry form with agreement, and fees, nor will telephone or FAX entries will be accepted. No more than 10 entries allowed per envelope.
- Owners are responsible for ensuring that entry forms are completed **IN FULL**. Entries submitted without ALL information will be returned as invalid.
- Returned checks do not constitute a valid entry. A \$30.00 service fee will be added for all returned checks.

INVALID ENTRIES

Invalid entries will be returned to the address on the entry form. The following conditions constitute an invalid entry:

- An entry which is missing any AKC required information
- Entries not on Official AKC forms OR on a photocopy of an AKC form without the current agreement and rules on the reverse side or attached to the entry form
- Entries which are illegible, incomplete, or received with insufficient fees
- Conditional, unsigned, incomplete, e-mail, telephone, FAX, or telegraph entries will not be accepted.
- Returned checks do not constitute a valid entry
- A maximum of ten entries per envelope is allowed. Envelopes with more than the ten dog maximum shall be treated as an invalid entry and shall be returned to the sender.

CONFIRMATIONS

- Confirmations will be sent via US mail **ONLY** if an exhibitor does not have an active e-mail address or upon specific request.
- A Preliminary Confirmation will be sent to the e-mail address on the AKC entry form after your entry has been processed. Please review the information in the confirmation for input errors and notify the Trial Secretary of any corrections.
- **Contact us if you do not receive a preliminary confirmation before the closing date!**
- Final confirmations of entry and judging schedule will be sent to the e-mail address on the AKC form after the closing date.

NOTE: If the exhibitor has not received the Final Confirmation within five days of the trial, please contact the Trial Secretary.

DOGS ELIGIBLE TO ENTER

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate.

HEIGHT DIVISIONS

Owners/Agents are responsible for entering the proper height divisions.

Simplified Jump Height Card Process

If your dog needs to be measured, check the box at the top of the entry form so that your dog is placed on the Measuring List. It is no longer required that you submit a copy of your dog's jump height card with your entry form or show it during day of show check-in.

RIBBONS AND AWARDS

Rosettes will be awarded to the first through fourth place dog in each jump height division in each class. Qualifying ribbons will be awarded to all dogs receiving a qualifying score. Dogs must qualify to receive placement ribbons. MACH/PACH Rosettes and a MACH/PACH bar will be given to exhibitors earning a MACH or PACH title at this trial. New title ribbons will be given to those earning a title. DoubleQ ribbons will be given for those earning a qualifying score in BOTH Master level STD and JWW, regular or preferred on the same day. All ribbons and prizes must be claimed the day of the Trial. None will be mailed.

NOTICE TO EXHIBITORS

The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

It is expressly understood that the exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In such case, no refund of any entry fees will be made.

Entry fees will not be refunded in the event that the dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.

No entry fee will be refunded if the trial cannot open or be completed by reason of civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

Exhibitors are responsible for being at the ring gate when it is their turn to run. No classes will be held up by a late exhibitor.

All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area. No dogs may be left tied to trees, cars, fences, etc.

Dogs under 4 months of age are not allowed at this trial.

ADDITIONAL SITE INFORMATION

*These agility trials will be held in an indoor arena on a sand/clay surface.
There is plenty of room for crating and lots of grassy areas for walking dogs.*

Please adhere to the following rules while at the site:

- No personal crates or chairs on the ground floor without approval of the Trial Chair. Handcapped crating and seating on floor or designated room only with approval of Trial Chair.
- Crates may be left overnight; however, SCCTC, DOTC and the Virginia Horse Center will not be responsible for any lost or damaged items left at the show site.
- Please be considerate of others and conserve crating space. Please leave aisle ways clear or we will have to move you.
- Please do NOT walk your dogs in any area that has been mulched or landscaped to include gardens, flower beds or shrubs.
- Do not allow your dogs to relieve themselves on trashcans and/or the building.
- Flexi-Leads **MUST** be kept at the 2' **LOCKED** position when used **IN** and **NEAR** the building.
- High occupancy X-Pens ARE allowed.
- A full service concession stand is available on site.
- **Exhibitors are responsible** for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

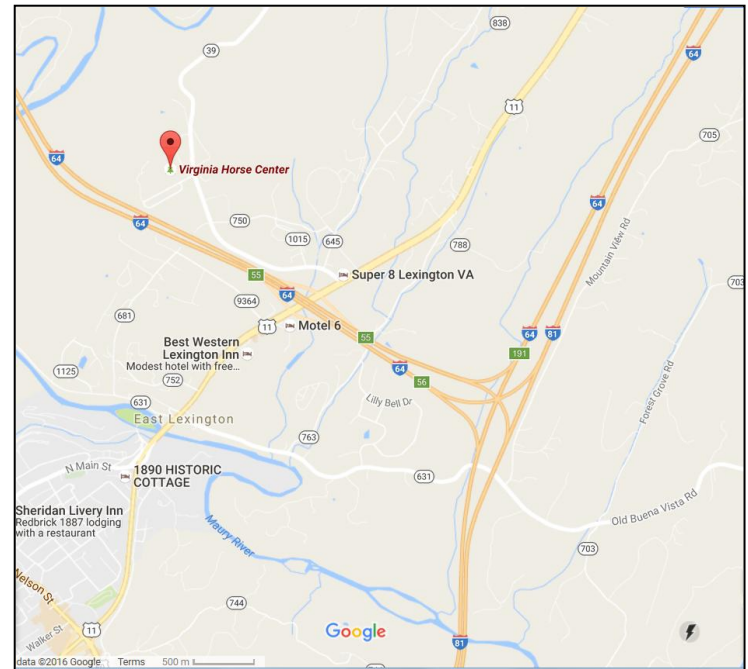

AGREEMENT

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of The American Kennel Club in effect at the time of this event, and any additional rules and regulations appearing in the premium list of this event and entry form and any decision made in accord with them. I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly by any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. INSTRUCTIONS

Handlers may opt to enter in a higher height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine PartnersSM program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767.
